98.9 MAGIC FM'S "AIR FORCE VS UNIVERSITY OF NEVADA, LAS VEGAS – SURVEY SAYS!" CONTEST OFFICIAL RULES

The Station will conduct the **"AIR FORCE VS UNIVERSITY OF NEVADA, LAS VEGAS – SURVEY SAYS!"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 3. How to Enter. Entrants must:

Listen to the Station weekdays during the Contest Period. When the Station plays the "Survey Says" sounder and game, listeners must call the Station at 719-715-0989. Be the first caller with

the correct answer to the Station, as determined by the Station in its sole discretion, to win. <u>Time</u> <u>Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
