98.9 MAGIC FM'S "BATTLE MMA CHAMPIONSHIPS - INSTAGRAM" CONTEST OFFICIAL RULES

The Station will conduct the "BATTLE MMA CHAMPIONSHIPS - INSTAGRAM" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - (c) Comment with the name of a celebrity or otherwise notable person, as determined by Station at its sole discretion;

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified.
