98.9 MAGIC FM'S "WHAT'S THAT COLORADO SOUND – DRAKE & J. COLE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KKMG-FM ("Station"), **6805 Corporate Dr.**, #130 Colorado Springs, CO 80919 during available business hours Monday through Friday, on the Station website www.989magicfm.com, or by sending a self-addressed, stamped envelope to the above address. The Station will conduct the "WHAT'S THAT COLORADO SOUND – DRAKE & J. COLE" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. 2. Contest Period. The Contest entry period will begin at 7:00am MST on January 4, 2024 and will run weekdays at or around 7:00am MST, 8:00am MST, 10:00am MST, 12:00pm MST, 1:00pm MST, 3:00pm MST, and 5:30pm MST, through 5:30pm MST on January 17, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter. Entrants must:

Listen to the Station during the Contest Period. At or around 7:00am MST, 8:00am MST, 10:00am MST, 12:00pm MST, 1:00pm MST, 3:00pm MST, and 5:30pm MST each weekday

(each, a "Selection Day"), when the Station plays either the "What's That Colorado Sound" or "Win Drake Tickets" sounders (each, the "Sounder"), listeners must call the Station at (719) 715-0989. Caller eight (8) to the Station, as determined by the Station in its sole discretion, will be the Potential Winner for that Selection Day after providing the Station the potential winning listener's name and phone number, subject to verification and compliance with these Contest Rules. The Potential Winner must correctly guess, as determined by the sole discretion of the Station, what the "Colorado Sound" is, to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- 4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
