98.9 MAGIC FM'S "PIKE'S PEAK PRIDE MARDI GRAS BALL" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KKMG-FM ("Station"), **6805 Corporate Dr., #130 Colorado Springs, CO 80919** during available business hours Monday through Friday, on the Station website <u>www.989magicfm.com</u>, or by sending a self-addressed, stamped envelope to the above address. The Station will conduct the "**PIKE'S PEAK PRIDE MARDI GRAS BALL**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days Void where prohibited by law. 2. Contest Period. The Contest entry period will begin at 3:00pm MST on February 7, 2024 and will run through 4:15pm MST on February 7, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter. Entrants must:

(a) Listen to Station during the Contest Period, at or around 3:00pm MST and 4:00pm MST;

(b) Call Station at (719) 715-0989 when prompted;

(c) The Potential Winner will be the eighth caller to Station, as determined by Station and its representatives at its sole discretion.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station will be deemed not entered in the Contest.

4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
